The Girl Scout Cookie Program is more than a fundraiser. It's the world's largest girl-led business, and a hands-on approach to teach girls 5 core skills (Goal Setting, Decision Making, Money Management, People Skills, Business Ethics) while they earn rewards and money to power Troop experiences. All proceeds from our Girl Scout Cookie Program stay local and benefit girls in Miami-Dade and Monroe counties.

Please read and discuss with your Girl Scout each statement below. These are requirements and expectations for your Girl Scout to participate in the Cookie Program.

- ❖ I will ensure my Girl Scout has adult supervision and follows safety rules at all times for Cookie Program activities. This includes ensuring online marketing and sales efforts are led by my Girl Scout, while also being supervised by a parent and/or caregiver. My Girl Scout and our family will review and adhere to the Girl Scout Internet Safety Pledge, Digital Cookie Pledge, Supplemental Safety Tips for Online Marketing, and Girl Scouts' Safety Activity Checkpoints for Computer and Internet Use.
- ❖ I will ensure my Girl Scout and our family follow GSUSA and GSTF ethics guidelines. This includes selling at the established Council prices, during published sale dates only, and conduct consistent with the Girl Scout Promise and Law.
- ❖ I will ask for, and obtain, a receipt for any cookies I pick up and payments I submit.
- ❖ I understand that I cannot exchange or return cookies (unless damaged), and I agree to accept full financial responsibility for all of the cookies that I order. If I anticipate needing assistance selling all our cookies, I will contact the Troop Cookie Manager as soon as possible and before the end of the sale.
- ❖ I will submit full payment for my Girl Scout's cookies to the Troop Cookie Manager by all required deadlines. All cookies obtained for my Girl Scout's sales will be paid for no later than the deadline given by the Troop Cookie Manager.
- ❖ I understand if I do not pay the full amount due for cookies by the deadline, my Girl Scout forfeits any Girl Rewards and I may be subject to interest, collection, and/or attorneys' fees on top of the amount due.
- ❖ I agree to meet all the deadlines given by the Troop Cookie Manager during the Cookie Program.

IMPORTANT COUNCIL DATES

Nov 20: Girls may begin taking pre-orders

Dec 2: Digital Cookie *tentatively* opens! Caregivers will receive an email to register, set up girl site and start the online sale.

Jan 18: Cookie Pick-Up Day! Direct Sales and Booth Sales begin. Troop Cookie Manager will give instructions to pick up the cookies ordered.

Jan 18 – Feb 23: Work on Cookie Business Badges and the Cookie Entrepreneur Family Pin. Turn in cookie money regularly and pick up more cookies if needed. Help at Cookie Booths if you can.

Feb 23: Last day for Direct Sales, Cookie Booths, and Digital Cookie. Don't forget to review the rewards card and let the Troop Cookie Manger know of any rewards that need to be selected.

May 2025: Cookie Program rewards distributed; Troop Cookie Manager will let caregivers know the exact date after they receive rewards from Council.



Digital Cookie lets girls create their own online business. Digital Cookie *tentatively* opens **December 2**. Caregivers will receive an email with the registration link.

Girl must setup their online site to email to previous customers, family and friends to promote your cookie business. They will be able to help you reach your goals. Customers purchase cookies to be delivered in-person, pay for shipping to their home, and/or donate cookies to our Hometown Heroes.

The Digital Cookie mobile app can take credit card payments starting **January 18**, but your online store must be setup beforehand to use this contactless and convenient feature.



Our Hometown Heroes program is how we say Thank You to our local and far away heroes. It is an easy way for customers to donate cookies to military, police officers, firefighters, EMTs, essential workers, healthcare workers, and others who serve our community.

Girls simply collect monetary donations. At the end of the cookie Season, Troops and GSTF distribute the cookies to our heroes. We donated a sweet salute of 10,000+ packages of cookies to our Hometown Heroes in 2024 – *Thank you!*
