### Sample Bequest Language

#### Specific Bequest

#### Percentage Bequest

#### Contingent Bequest

#### Restricted Bequest

We recommend that you also add: “If, in the opinion of the Board of the Girl Scout Council of Tropical Florida, Inc., it shall be impossible for the Girl Scout Council of Tropical Florida, Inc. to use this bequest to accomplish, the Girl Scout Council of Tropical Florida, Inc. may use it for any related purpose as deemed by the Board of the Girl Scout Council of Tropical Florida, Inc.”
